### **NEET UG (M.B.B.S.) 2023-24 Admission at Constituent Medical Colleges of MGM Institute of Health Sciences, Navi Mumbai**

As per the Hon'ble Supreme Court of India, Directorate General of Health Services (DGHS) guidelines, admission counseling for all UG (M.B.B.S.) seats of the Deemed Universities will be done by DGHS/MCC. Therefore the process of UG Admission (M.B.B.S.) for constituent Medical Colleges of MGM Institute of Health Sciences, Navi Mumbai will be as follows:

- All NEET UG-2023 qualified candidates who are interested in getting admission at following constituent Medical Colleges need to select these colleges as their choice on **MCC portal** of DGHS.
  - Mahatma Gandhi Mission Medical College, Navi Mumbai (200368)
  - Mahatma Gandhi Mission Medical College, Vashi (200654)
  - Mahatma Gandhi Mission Medical College, Aurangabad (200367)
- Seats distribution of MBBS programs for the academic year 2023-24** (This is the actual intake capacity of each college at start of counseling). For actual vacant seats after each round applicants need to check the updated seat matrix on the MCC website.

- Selected candidates in each counseling round need to report to Deans of respective Medical Colleges of MGMIHS as per the instruction of DGHS/MCC during defined reporting period only of each round. It is further advised to report in the earlier part of reporting period to avoid last minute unforeseen issues. Reporting time is 10.00 am to 04.00 pm on all days (including Saturday, Sunday and Public holiday) during reporting period. The process of reporting and admission may take time therefore, candidates need to plan their travel and stay accordingly.
- At the time of reporting, candidates must submit:
  - The requisite annual tuition fee of the 1<sup>st</sup> year in the form of demand draft favoring "**MGM Institute of Health Sciences**". DD should be Payable at Navi Mumbai. Students can pay in Multiple DD's (of same bank / different bank) with amount totaling to the total fees. Kindly note that the annual tuition fees will remain same for each year (entire duration) of the MBBS course (4 & ½ year).

- Full tuition fee of 1st year has to be paid at the time of admission. No Installment facility is permitted.

- For Management Paid Seats, tuition fee has to be paid from student / parent account only.
  - The NRI fees as shown in US dollars need to be paid based on the conversion rate prevailing on the day of admission. However, if the converted amount goes below Rs. 45,00,000/- INR then INR 45,00,000/- needs to be paid as tuition fees. If the converted rate is higher than Rs. 45,00,000/- then higher amount will be the tuition fees on that day.
  - NRI students must pay the annual tuition fee from his/her sponsorer's NRI Bank account only.
  - If fees, is to be paid by RTGS, student must report first to the respective medical college and submit the documents for verification. After verification of documents, he/she can pay the fees by RTGS. Kindly note that RTGS mode to be avoided during last 2 days of reporting period because unforeseen banking delay may lead to non-receipt of tuition fees. Thus, admission may not be granted in such a case.
  - All the documents in original OR through 'DigiLocker' as per check list attached with this notification (**Annexure -01**) with two sets of self-attested photocopies.
  - Without original documents and demand drafts of Tuitions Fees candidate will be considered as '**Non Reported**' even if he/she is allotted for a particular round and has visited the medical college.
  - Students himself/herself must be present to the respective Medical College at the time of reporting. **No proxy will be allowed in any circumstances.** Candidate must join the college as per the instructions of respective Dean's office/MCC/NMC.
  - All candidates are informed that if the term (college) has already started they need to join the college immediately after completing the admission formalities.
  - Only physical reporting is permitted. No online reporting is allowed.
5. **University Eligibility fees** need to be paid after joining the course (**Annexure- 02**) for which separate notification will be issued later.

**Other fees** (Hostel fees, Mess fees, Library fees, Gymkhana fees, Security deposit and miscellaneous charges) need to be paid at the college level. For further information regarding other fees, please click on the below constituent Medical college website OR write an email:-

6. Other fees will be required to be paid only if candidate has decided to retain the seat in the allotted college.
7. All original documents will be returned to the student after verification and granting of eligibility by the University at a later stage.
8. Candidates are requested to strictly adhere to counseling schedule/scheme put up on [www.mcc.nic.in](http://www.mcc.nic.in) website.
9. 'Seat surrender' (For any valid reason) by any student as per MCC guidelines after securing admission will be done after deduction of Rs. 10,000/- as administrative charges from the paid tuition fees and rest amount of 1<sup>st</sup> year tuition fees will be refunded back to the designated bank account of student/parent within 3 bank working days excluding the day of receipt of seats surrender request at the medical college office.
10. The registration charges if any paid to MCC is not part of tuition fees. Any clarification therefore, may be held with MCC only.




